Information on Admission in the 2020/21 School Year

Eligibility Criteria

K1: was born on or before 31 December 2017 (2 year 8 months)

K2: was born on or before 31 December 2016

K3: was born on or before 31 December 2015

Collection of application forms

Distribution and submission of application forms (No set quota for the kindergarten)

1. Date: 3/9/ 2019 (Tuesday) to 31/10/2019 (Thursday)
2. Time: 9:00am to 4:00pm (Monday to Friday)
3. Submission: Submit the application form in person / by post together with a copy of Birth Certificate and Immunisation Record. For those applications by post, please bring the above originals for verification on interview. And 4 self-addressed stamped envelopes (\$2.0 stamp) specifying the name and address of the applicant.
4. Application fee: HK\$40 (to be collected together with the application form). The application fee is non-refundable whether the application is successful or not.
Please do not send cash through the mail. Crossed cheque payment can be made by post. Cheque payable to "St. Peter's Church Kindergarten"

Application for the 2020 - 2021 "Registration Certificate for Kindergarten Admission"

1. The Education Bureau (EDB) has implemented the " Free Quality Kindergarten Education Scheme", to replace the "Pre-primary Education Voucher Scheme", since 2017 – 2018 school year. Under the new scheme, EDB will accept " Registration Certificate for Kindergarten Admission" as the registration document for K1 students in 2020-2021 school year.
2. Parents are required to submit an application for the "Registration Certificate for Kindergarten Admission" (hereafter referred as "RC") to EDB from **September to November 2019**. The "RC" will be open for applications in September 2019 and EDB will announce and upload the details of application onto EDB's website (<http://stpstkg.edu.hk>) in due course.

Admission Criteria

1. Interview performance
2. The applicant with sibling(s) currently or previously studying in the kindergarten, children of our staff and children of our church will be given due priority consideration.

Interview Arrangements

1. The kindergarten will arrange interview for all applicants.
2. Interviews will be conducted on 23/11/2019 (Saturday). The details will be informed by post.
3. Group and individual interviews will be arranged.
4. One parent should accompany his/ her child for the interview.

Announcement of Admission Results

We will inform parents the admission results before **21 December 2019** by post.

Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child from 9 to 11 January 2020 (“Centralized Registration Dates”) by submitting the “RC” to the kindergarten and paying the registration fee.
2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the “RC” to the kindergarten and pay the registration fee.
3. Please be reminded that if parents cannot submit the “RC” during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to EDB within the specified period.
4. The registration fee for 2020/21 is HK\$970. If the child studies in the kindergarten, the registration fee paid will be refunded in October. Should parents decide to change school after registration, please notify the kindergarten in writing. The kindergarten will return the “RC” but the registration fee will not be refunded. Upon obtaining the “RC”, the Kindergarten will no longer keep the school place for the child.
