申請「2024-2025 幼稚園入學註冊證」：

1. 教育局於 2017-2018 學年起推行免費優質幼稚園政策，以取代現有的「學前教育學券計劃」。在新計劃下，教育局會以「幼稚園入學註冊證」作為 2024-25 學年的 K1 註冊文件。
2. 家長須於 2023 年 9 月至 11 月期間為其子女向教育局申請「幼稚園入學註冊證」。「幼稚園入學註冊證」會於本年 9 月開始接受申請，屆時教育局會公布申請細則，並會在教育局網頁(http://www.edb.gov.hk/free-quality-kg-edu_tc)上載詳情。

收生準則：

1. 面試表現。
2. 申請人的兄弟姊妹正在本園就讀、本園教職員之子女及本堂教友之子女獲優先考慮。

面見安排：

1. 本園會安排面見所有申請入讀的兒童。
2. 面見於 2023 年 11 月 4 日(星期六)進行，本園會另函通知家長。
3. 以小組或個別形式面見。
4. 須一位家長陪同參加面見。
5. 在面見非華語兒童時，學校可按需要為申請人安排翻譯 服務，家長和兒童亦可由懂中文的親友陪同會面，協助溝通。

取錄結果詳情：

1. 公佈日期：2023 年 12 月 15 日前(以郵寄形式通知)
2. 正選生：家長須於 2024 年 1 月 4 日至 6 日(統一註冊日期)內的指定時間到本園辦理註冊手續，並須提交「2024-25 註冊證」正本及繳交註冊費。
3. 備取生：本園會發出通知，請家長於指定日期到本園辦理註冊手續，並須提交「2024-25 註冊證」正本及繳交註冊費。
4. 家長請留意，如未能在指定的註冊日期提交有效的註冊文件，本園或未能為獲取錄兒童完成手續，因此家長務必於指定日期內向教育局申請相關註冊證。
5. 2024-25 學年的半日班註冊費為港幣 970 元正，本園會於 2024 年 10 月退回註冊費。全日班註冊費為港幣 1,570 元正將會於首月開始作學費扣減，但若家長於註冊後決定為子女轉校，請以書面通知本園。本園會退回相關註冊證，但註冊費將不獲退還。在取回註冊證後，本園亦不會再為該兒童保留學位。

Application for the 2024- 2025 “Registration Certificate for Kindergarten Admission”

1. The Education Bureau (EDB) has implemented the “ Free Quality Kindergarten Education Scheme”, to replace the “Pre-primary Education Voucher Scheme”, since 2017 – 2018 school year. Under the new scheme, EDB will accept “ Registration Certificate for Kindergarten Admission” as the registration document for K1 students in 2024-2025 school year.
2. Parents are required to submit an application for the “Registration Certificate for Kindergarten Admission” (hereafter referred as “RC”) to EDB from **September to November 2023**. The “RC” will be open for applications in September 2023 and EDB will announce and upload the details of application onto EDB’s website (<http://stpstkg.edu.hk>) in due course.

Admission Criteria

1. Interview performance
2. The applicant with sibling(s) currently or previously studying in the kindergarten, children of our staff and children of our church will be given due priority consideration.

Interview Arrangements

1. The kindergarten will arrange interview for all applicants.
2. Interviews will be conducted on 4/11/2023 (Saturday). The details will be informed by post.
3. Group and individual interviews will be arranged.
4. One parent should accompany his/ her child for the interview.

Announcement of Admission Results

We will inform parents the admission results before 15 December 2023 by post.

Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child from 4 to 6 January 2024 (Centralized Registration Dates) by submitting the “RC” to the kindergarten and paying the registration fee.
2. Applicants on the waiting list: The kindergarten will notify by phone. Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the “RC” to the kindergarten and pay the registration fee.
3. Please be reminded that if parents cannot submit the “RC” during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to EDB within the specified period.
4. The registration fee for 2024/25 for half-day class is HK\$970. If the child studies in the kindergarten, the registration fee paid will be refunded in October. The registration fee for the whole day class is \$1,570. Instead this will be absorbed into the school fee for the month of September & October. Should parents decide to change school after registration, please notify the kindergarten in writing. The kindergarten will return the “RC” but the registration fee will not be refunded. Upon obtaining the “RC”, the kindergarten will no longer keep the school place for the child.
